**As of 7/7/2023:** Standards for the Appropriate Use of Facial Coverings for Infection Control at the Edward J. Healey Rehabilitation and Nursing Center

Health care providers, contractors, students and volunteers are no longer required to wear facial coverings. Facial covering may be encouraged for anyone that is exhibiting signs or symptoms of or has a diagnosed infectious disease that can be spread through droplet or airborne transmission. Health care providers, contractors, students, visitors and volunteers have the right to Opt-Out of wearing facial coverings. Health care providers will be required to wear facial covering when: conducting sterile procedures, working in a sterile area, working with a patient that has been diagnosed with or confirmed of having an increased risk of transmission of an infection and the practitioner has determined the use of facial coverings necessary for the patient's safety or with a patient is on droplet or airborne precautions.

### From I-95

Exit at Blue Heron Blvd., drive west for 0.5 miles, cross Military Trail, make first left into the campus.

### From Florida's Turnpike

Exit at PGA Blvd. (Exit 109). Left on PGA Blvd., east to Military Trail, turn right and drive south to Blue Heron Blvd. Turn right and make first left into the campus.

If you have SunPass: Exit at SR 710/Bee Line Hwy. (Exit 107). Turn left onto Bee Line Hwy. and drive south for 1.9 miles. Turn left onto Blue Heron and make the second right into the campus.
