# A. MOTION TO APPROVE:

Lakeside Medical Center 2015-2018 Implementation Strategy.

Dawn Richards presented this agenda item and discussed that under the ACA (Affordable Care Act) each hospital organization is required to conduct a Community Health Needs Assessment (CHNA) and adopt an implementation strategy at least once every three years. The Lakeside Health Advisory Board adopted the initiative to address diabetes in the Glades community as a result of CHNA.

CONCLUSION/ACTION: Ms. Weeks made a motion to approve the Lakeside Medical Center 2015-2018 Implementation Strategy reflecting the actions they have taken since 2015. The motion was duly seconded by Ms. Hale. A vote was called, and the motion passed unanimously.

#### B. RECEIVE AND FILE:

Lakeside Medical Center Update.

Stephanie Dardanello presented this update. She gave a six month overview of what has been established since becoming the LMC's administrator. The presentation included hiring updates, implementing departmental meetings, conducting mock review for the Joint Commission visit, and beautification of hospital grounds and building. The Board was also notified of a diabetes event in conjunction with the Diabetes Coalition of Palm Beach County on June 10, 2018 at the United Methodist Church in Belle Glade. This event is one of the action items from the Lakeside Medical Center's 2015-2018 Implementation Strategy.

Telemedicine.

Dr. Andric presented the Primary Care Clinics Unified Data System (UDS) Summary. This is required by HRSA once a year. She also discussed the advantages of Telemedicine, such as the care and cost advantages, reduction of unnecessary ER visits and avoidable readmission. Dr. Andric presented an update on the Primary Care Clinics integrated behavioral health plan, which will increase access to mental health care, decrease barriers to receiving mental health care and improve collaboration with existing community partners.

Darcy Davis updated the Board on employment changes that have occurred at the Health Care District since the last Lakeside Health Advisory Board meeting in February.
