Skilled nursing and rehabilitation for residents who require 24-hour inpatient care as a result of debilitating illness or traumatic injury.

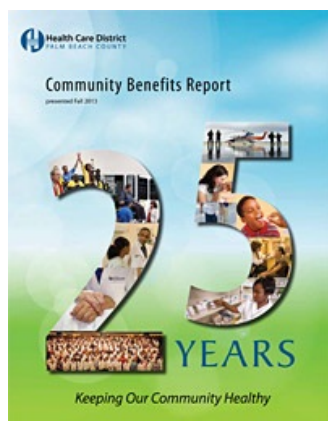


Health coverage for residents who cannot afford private health insurance and do not qualify for government health programs.
