primary governance over the Medical Staff and serves a liaison between

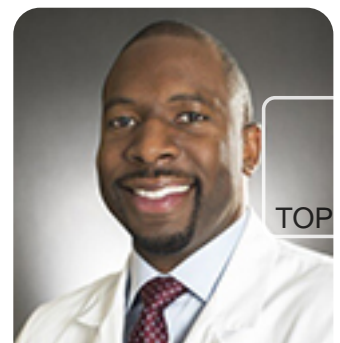
the Medical Staff, Hospital Administration and the Governing Board.
