OB and ACGME Update Site Visit (Karen Harris) [Verbal]

Karen Harris provided the following updates:

1. ACGME Program (Accreditation Council for Graduate Medical Education)
 - The institution is already accredited and the program is going through the final stages on getting accredited.
 - A site visit was held in the beginning of November 2022 and lasted most of the day. It went extremely well.
 - The site visitor spoke and asked various questions to Dr. Jennifer Dorcé-Medard, D.O., Program Director, Assistant Program Director, Residents and Karen Harris.
 - The site visitor loved the video that was provided of the clinics.
 - The ACGME Committee will review the site visitor findings and provide the outcome by February or March 2023 and hopefully the next site visit will be in 10 years.
 - Darcy Davis stated that it is worthy to mention Dr. Jennifer Dorcé-Medard's dedication. She came in to meet with ACGME and had just delivered her baby.
2. OB
 - As of December 21, LMC will not be providing OB services.
 - Partnering with Palms West Hospital and other hospitals, in the community.
 - The Communications Department will be doing a campaign in English, Spanish and Creole so that everyone in the community is aware.
 - The OB patient will be stabilized and transferred to Palms West Hospital or Wellington Regional Medical Center.

2. Three-dimensional (3D) Mammography – Senographe Pristine Digital Breast Tomosynthesis (GE Healthcare)
 - It is the latest technology innovation for women healthcare.

3. Holigic and Siemens are two other vendors that will show their 3D Mammography, as well.

A selection will be made on which 3D will be purchased.
