The purpose of this bulletin is to inform all participating providers that updates have been made to the pharmacy network for the following Health Care District programs: Coordinated Care Option 1, Option 2, Option 3/Ryan White, MCP, and the Trauma program.

OVERVIEW

Effective October 16, 2010

The Health Care District pharmacy network will no longer include Walgreens, Walmart, Winn-Dixie, or Target locations. The pharmacies that will continue to participate in the HCD network include:

CVS Pharmacies, Publix Pharmacies, the Health Care District pharmacies located at the Health Department Health Centers, and the contracted independent pharmacies (see complete list on page 2 of this bulletin).

The members have all been notified via mail of the change. However, we are requesting that our providers assist their patients as new prescriptions are written or in situations where assistance is needed transferring any prescriptions.

For your patients who are not currently using one of the updated in-network pharmacies they will need to go to one of them and ask that the pharmacist

request to transfer their prescription from their old pharmacy to their new pharmacy. To make it easier, your patients can bring the prescription bottle to the new pharmacy and they will help the member transfer the prescription.
