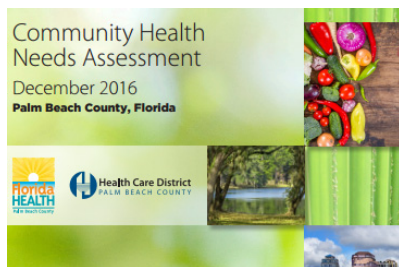

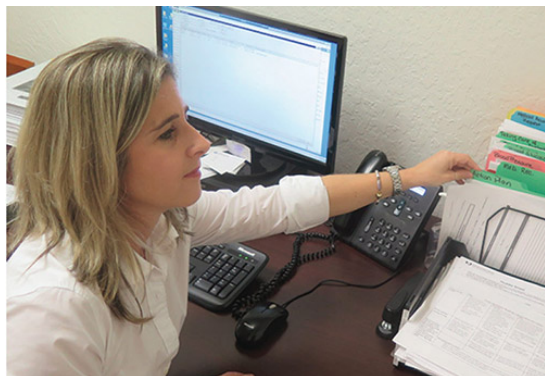
The 2016 Palm Beach County community health assessment helps provide a better understanding of the needs of the community and aid in planning for services.
