Tammy Jackson-Moore Appointed to Serve on the Health Care District of Palm Beach County Board

Tammy Jackson-Moore was recently appointed by the Palm Beach County Board of County Commissioners to serve a four-year term on the Board of the Health Care District of Palm Beach County. Ms.

Jackson-Moore was sworn in by Commissioner Leslie B. Daniels, Board Chair at the Board's public meeting on December 10, 2019.

She is the co-founder of Guardians of the Glades, an advocacy organization that works on behalf of the Glades communities.
