The celebration featured the grand opening of the new C. L. Brumback Primary Care Clinics inside the hospital, which provides medical, dental, pharmacy and behavioral health services for adults and children – all under

one roof.

The proclamation recognizes “Lakeside Medical Center on the occasion of its 10th Anniversary of providing residents and visitors in rural, Western Palm Beach County with safe, quality hospital care.”

Janet D. Moreland, Hospital Administrator, publicly thanked the Commission for the recognition and invited them to the event.
