- Health Care District Shifts Gears with Mobile Clinic as Vaccination Interest Plummets - After crisscrossing the county to make it more convenient for people to get vaccinated against COVID-19, one of the Health Care District of Palm Beach County's three mobile clinics will return next month to its pre-pandemic duties: providing primary care services to homeless and underserved adults. The Health Care District continues offering adults and children as young as 12 free, walk-up COVID-19 vaccinations with a second mobile clinic stationed in the Lantana Clinic parking lot at 1250 Southwinds Drive in Lantana Monday through Friday from 9 a.m. to 4 p.m.
- Health Care District Updates Mobile Clinic Vaccination Schedule - Due to low interest in COVID-19 vaccinations, yesterday was the final day of the Health Care District of Palm Beach County's mobile clinic vaccination outreach at the Vote and Vax Electoral Primary events at Palm Beach State College's Loxahatchee Campus and the Belle Glade

Library.

- Health Care District's C. L. Brumback Primary Care Clinics Awarded \$1 Million Federal Grant for Medical and Office Equipment - To expand access to quality patient care, the C. L. Brumback Primary Care Clinics plan to relocate three of their nine brick-and-mortar clinics to more spacious and modern health centers. The Health Resources and Services Administration (HRSA), an agency of the U.S. Department of Health and Human Services, awarded a grant of \$1,010,224 this month to fund new medical equipment and furnishings for these sites that are located in medically underserved areas of Palm Beach County.
- Health Care District's Public Service Announcements Ask the Public to "Listen to Someone You Trust" about Getting the COVID-19 Vaccine - At a time when interest in first-doses of the COVID-19 vaccine is waning at the Health Care District of Palm Beach County's mobile clinics, the agency's Chief Executive Officer is encouraging the public to listen to those they trust about their experience getting vaccinated against COVID-19.
