Health Care District of Palm Beach County Collaborates with the Area Agency on Aging to Protect Seniors

The Health Care District of Palm Beach County and the Area Agency on Aging of Palm Beach and Treasure Coast (Agency) are collaborating to protect seniors during the ongoing pandemic. The Health Care District's C. L. Brumback Primary Care Clinics supplied several boxes of N95 masks and COVID-19 test kits at no cost to distribute to aging network providers and senior volunteers who deliver educational programs in the public schools.

Davis, CEO of the Health Care District of Palm Beach County. “The Health Care District is a leader in countywide COVID response, from mobilizing the first mass vaccination and drive-thru testing sites to ongoing efforts in our primary care clinics and school health program that serve and safeguard adults and children. These extra layers of protection for seniors will benefit some of the most vulnerable in our community.”

Older adults and people with disabilities—particularly those from underserved communities—have been disproportionately impacted by the pandemic and are among the most at-risk due to COVID-19. Partnerships between community providers and aging and disability networks can be an important strategy for supporting those most at risk.

Most of the N95 masks and home test kits will be distributed to aging network providers who provide direct services to seniors, including access to community centers, adult day care, congregate meal sites, home-delivered meals and other home-based services. Safety is a critical element to delivering services to seniors. Participating aging network providers include; Palm Beach County Division of Senior and Veteran Services, MorseLife, Alzheimer's Community Care, Ruth and Norman Rales Jewish Family Services, Legal Aid Society of Palm Beach County and The Volen Center.

The Volen Center at 1515 W. Palmetto Park Road in Boca Raton will hand out a portion of the adult facemasks to seniors tomorrow, Wednesday, March 23rd from 12 pm to 1 pm. The media is invited.

seniors with volunteer opportunities to mentor and tutor young students in

public school classrooms. Protecting both the senior and young vulnerable populations is of paramount importance.

The Agency serves as a gateway to services for seniors and operates a helpline that assists seniors with information and referral and navigating to services addressing activities of daily living and social determinants of health. The Helpline may be reached by calling 1-866-684-5885, Monday through Friday from 8:00AM to 5:00PM.

This collaboration is possible thanks to the Health Resources and Services Administration (HRSA) which sent the supplies to the Health Care District's network of ten primary care clinics located in areas of need across Palm Beach County. The Brumback Clinics are Federally Qualified Health Centers that provide access to medical, dental, pharmacy and behavioral health services to adult and pediatric patients regardless of their ability to pay.

"The Area Agency on Aging is grateful for the collaboration and support from the Health Care District," said CEO Dwight D. Chenette, MPH, MBA. "In this time of uncertainty, ongoing protection of our vulnerable populations is a high priority. As the "health care safety net for Palm Beach County", we value our partnership with the Health Care District."
