Health Care District Board Welcomes Three New Members and Honors Outgoing Chair

At its first public meeting of the year on January 26th, the Health Care District of Palm Beach County's Board welcomed three new members appointed last month by Governor Ron DeSantis. Tracy Caruso, Patrick Rooney and Carlos Vidueira will each serve a four-year term. They joined Alina M. Alonso, MD, outgoing Chair; Sean O'Bannon, Vice Chair and Tammy Jackson-Moore, Secretary.

"We are pleased to welcome Ms. Caruso, Mr. Rooney and Mr. Vidueira to the Health Care District Board," said Darcy J. Davis, Health Care District ^{TOP} CEO. "They each bring extensive experience and leadership in business,

At the meeting, the Board elected Mr. Vidueira as the new Chair. Mr. Vidueira is the Vice President of Huizenga Holdings, Inc. and serves as Chairman of the Board of Directors of Northend RISE in West Palm Beach.

During the meeting, Ms. Davis recognized Dr. Alonso for her dedication and volunteer service since joining the Board in 2009. Dr. Alonso is retiring this year from her post as Director of the Florida Department of Health for Palm Beach County. That position holds a standing seat on the Health Care District Board.

“It’s been an honor to serve on the District Board and committees for nearly 14 years,” said Dr. Alonso. “I am proud that we expanded our network of primary care clinics, introduced care for behavioral health and substance use disorder, rolled out three mobile clinics and mobilized a countywide response to the COVID-19 pandemic.”

“Dr. Alonso is a passionate public health leader and advocate who helped pave the way for our public healthcare system to meet the changing health care needs of our community,” said Ms. Davis. “It’s been a pleasure to work with her and she will be missed.”

The Health Care District of Palm Beach County is a special taxpayer-funded district that has served as a health care safety net for over 30 years to fill in gaps in access to health care services. This unique health care system covers the entire county and provides diverse services such as 13 outpatient clinics (Federally Qualified Health Centers) which serve everyone regardless of ability to pay; school health clinicians staffed in nearly 170 public schools; two Trauma Hawk aeromedical helicopters; a rural, public teaching hospital, Lakeside Medical Center; a skilled nursing facility, the Edward J. Healey Rehabilitation and Nursing Center; a specialty

benefits program for eligible, uninsured residents; and quality performance oversight of the county's lifesaving trauma system.
